Executive Summary

Overview of M&A Activity:

- In the midst of the prevailing economic and geopolitical circumstances, merger and acquisition activity has declined significantly. While central banks around the world struggled to contain inflation, the M&A market remained subdued amid further geopolitical uncertainties stemming from the wars in Ukraine and Gaza. In 2023, the global number of transactions fell from 1,243 in 2022 to 893 with a reported transaction volume of € 60 billion compared to € 91 billion.
- The quarter-on-quarter trend was also comparable. There was no significant increase in the number of transactions. Some large acquisitions, including the take-private transaction of Qualtrics (USA) in the first quarter, the acquisition of SimCorp (DNK) by Deutsche Börse in the second quarter and the acquisition of Alteryx (USA) in the fourth quarter, were the main drivers of the transaction volume. There was no significant improvement in the fourth quarter of 2023 compared to the fourth quarter of 2022 due to the high cost of capital.
- In the DACH region, the number of transactions in 2023 fell by 41.5% compared to the previous year.
- In 2023, median valuations stood at 2.2x of revenue, remaining relatively steady compared to the levels observed in 2022, which were at 2.3x. However, the valuations are still far below the peak valuations witnessed during the COVID-19 pandemic, which reached 3.9x of revenue.
- SaaS-based businesses have also seen a decline in deal activity both in terms of volume and value. The median revenue multiple also fell from 5.8 in 2022 to 4.6 in 2023.


B2B Software Sector: Slower M&A Activity in 2023




B2B Software Sector: Quarterly Deal Volume 2018-2023



Median EV/LTM revenue multiples by type of buyers












B2B Software Sector Europe: Quarterly Performance of Share Prices




